



## Circular-Note for Fee Reconciliation

Dear Sir/Mam,

E-Campus Upload has been done for E-Campus Circular named Note for Fee Reconciliation with below details.

Dear Parents,

We have been receiving numerous inquiries from the few parents about the fixation of fees, etc. as per Hon'ble FRC Order.

In this connection we would like to inform you as follows:

We had submitted our Fee proposals to the Hon'ble FRC for the years 2017 -20218 onwards till 2024-2025 for fixation of the Fee.

The Hon'ble FRC had fixed the fees for the yeas 2017 -20218 onwards till 2024-2025.

Meanwhile we had sent the Circular to all the parents to pay the provisional fees which was subject to final Order of the Hon'ble FRC /High Court .

All of you have cooperated with us and made the payment of the provisional fees as notified by the school.

Hon'ble FRC didn't allow us to charge the Term Fee and admission Fee etc.

School is entitled to charge Term fees and Admission fees as per the provisions of Gujarat Self-Financed Schools (Regulations of Fees) Act 2017.

Accordingly, our school along with various other schools/school associations in Gujarat had approached and filed Writ Petition during the year 2022 and prayed to the Hon'ble High Court to allow us to charge the Term Fee and admission fee, etc. and also direction by the Hon'ble High Court to the Hon'ble FRC to determine the Fee as per the provisions of the Gujarat Self-Financed Schools (Regulations of Fees) Act 2017.

Hon'ble Gujarat HC has passed the Order dated 22.7.22 and held that schools are entitled to charge Term and admission fee over and above the fees determined by Hon'ble FRC.

Hon'ble Gujarat HC has also held that FRC shall allow all the expenses which are incurred by the school for imparting school education.

The State Government had filed an Appeal against the said Order dated 22.7.2022 before the Hon'ble Gujrat High Court.

Hon'ble Gujarat High Court has dismissed said Appeal of the State Government by the Order dated 19.4.2024.

We have also received the FRC Order dated 30.1.2025 for the fee fixation for the year 2024-25, 2025-26 and 2026-27.

You would appreciate that the matter regarding fixation of Fee etc. was under litigation for about last few years. Accordingly, we could not undertake the exercise of Fee reconciliation such as recovery and refund of fees etc.

Now there is clarity about the Fee matter. Accordingly, we have almost completed our reconciliation of Fee such as recovery and refund of fees.

In view of the of the above facts, we have already started the process of refunding the extra fees paid by the parents and will start recovering of the unpaid fees.

We hope that parents will appreciate the delay in undertaking the exercise of fee reconciliation, was purely due to the pending litigation before the Hon'ble High Court.

We therefore request all the parents to Co-operate in this regard to close this outstanding fee reconciliation matter.
